The Scovell Scholarship Foundation honors the legacy of longtime Dallas ambassador and Cotton Bowl Team Selection Chairman Field Scovell and his wife Mary, who shared a passion for young people and education.

Established in 1991, the Scovell Scholarship Foundation annually awards thousands of dollars in scholarships to North Texas youths with high moral character, leadership abilities, financial need and a connection to sports.

What is the Scholarship? A one-year scholarship award of \$3,000 paid in full directly to the higher education institution in August 2012. The scholarship may be renewable through the E.E. "Buddy" Fogelson Grant. Winners will be notified by April 2012.

Who Qualifies? The applicant must:

- Be in the graduating class of a North Texas high school (public, private, or parochial) or have a GED.
- Demonstrate financial need
- Be of high moral character
- Possess leadership qualities
- Be involved in extracurricular activities such as sports, band, school clubs, etc.
- Graduate with a "C" or equivalent class grade point average
- Attend an institution of continuing education within the State of Texas (junior colleges included), Big 12 Conference, or Southeastern Conference, the two conferences affiliated with the AT&T Cotton Bowl Classic.
- Attend a spring awards reception in Dallas on or about May 21, 2012.

Application Requirements:

- Completed application form
- Completed financial information form
- Copy of parent/guardian's most recent Federal Income Tax return

- Photo (head shot) to be published if awarded the scholarship. (Judges will not have access to photos when considering applications).
- At least two letters of recommendation
