What a special needs trust does

A special needs trust can help you to provide for your child after your passing and minimize the impact on their ability to receive Social Security and Medicaid benefits.

By setting up a special needs trust you can put money aside for your child (the beneficiary) and appoint a trustee to oversee how the money is spent. The trust would pay for the designated expenses — including personal care, education, physical therapy and more.

Choosing a trustee carefully is an important part of setting up a special needs trust, so an attorney can talk through the responsibilities involved and help you determine who would be best suited.
