The Human Services Career Cluster focuses on preparing individuals for employment in career pathways that relate to families and human needs such as counseling and mental health services, family and community services, personal care services, and consumer services.

Cosmetology



Cosmetology is a three-year program designed to provide students with the technical skills to become a licensed Cosmetology Operator. Cosmetologists provide personal beauty service to customers in hairstyling, bleaching, tinting, permanent waving, scalp and hair conditioning, hair cutting, facials and manicures. Cosmetology students participate in classroom instruction as well as laboratory-based instruction and evening salon nights to gain the required knowledge and skills for the Cosmetology Operator license. The Texas Cosmetology Commission requires that a public-school student complete a minimum of 1,000 laboratory hours of cosmetology concurrently with 500 hours of successful academic instruction.
